Homework Club is also authorized to take appropriate measures, including contacting the emergency medical services (EMS) system and arranging transportation to a medical facility.

Furthermore, we for ourselves and on behalf of our child-participant if under the age of 21 years hereby assume all risk of personal injury, sickness, death, damage, and expense arising from participation in recreation and activities involved in the program. Further, we give authorization and permission to the Homework Club to furnish any necessary transportation, food, and lodging for the participants for the program activities. The undersigned agree(s) to hold harmless and indemnify, on behalf of the signor and named participant, St. Jane Frances and Homework Club, its officers, directors, members, agents,

servants, volunteers, and employees, for any damages, or third-party claims for indemnity, sustained as the result of the negligent, willful or intentional acts of the undersigned participant, including any expenses incurred by Homework mClub related to such acts. Unless this document is signed by a participant who is over 21 years old, by signing below my signature confirms I am the parent or legal guardian of the participant. I grant permission for him/her to participate fully in any activities during this program. By signing below, I give permission to Homework Club and/or its agent(s) to take the named participant to a doctor or hospital if a medical emergency occurs. If I or my designated emergency contact cannot be reached by telephone or other means in a reasonable amount of time, or in an emergency situation where time is of the essence, I authorize medical treatment, including but not limited to emergency surgery or medical treatment, to stabilize the participant if needed, and I assume the responsibility of any medical bills arising from that treatment. Further, if circumstances require the participant to leave the program for the day due to medical reasons, disciplinary action, or otherwise, the undersigned hereby assumes responsibility for all transportation costs. Parent Handbook

Arrival and Pick-up

To ensure the safety of the students in our care, Homework Club has implemented the following procedures: 1. Students will only be released to adults authorized in the application by the parent(s). Identification will be checked before any student is released until the staff becomes familiar with the individuals who pick up students. 2. Daily attendance will be taken, and parents will be notified by a text message to their primary caretakers' cell phone if their child is not at the Homework Club location after 10 min of their scheduled time. 3. Each student must be signed out by an adult identified in the Identification and Emergency Information form. Students will not be released to anyone not listed on the emergency form. 4. It is critical that the information on the emergency form is current. If there are any changes, please let our staff know. 5. Homework Club will not provide any type of transportation for drop-off or pick-up. These measures are in place to ensure the safety and well-being of all students under our care. Thank you for your cooperation and understanding.

Absence Policy

Research consistently demonstrates that students who maintain consistent attendance and punctuality tend to achieve greater success in school. Parents play a crucial role in supporting their child's academic journey by ensuring they arrive on time and attend regularly. At Homework Club, we hold all students to these standards to maximize their learning potential. It's imperative for students to commit to and respect their assigned schedules. Absences are only excused in cases of infectious diseases. We require a minimum of 2 weeks prior notification for all absences; failure to provide timely notice will result in non-reimbursement due to space limitations and enrollment restrictions. When we schedule a student, we dedicate our full attention and allocate a designated staff member to ensure their success. We are committed to providing each child with the support they need to thrive academically. Please note that termination of the contract requires a 4-week prior notice.

Behavior

At Homework Club, we strive to cultivate a safe and nurturing environment where students feel valued, respected, and happy. Our aim is to foster a sense of belonging and inclusivity, creating a space where students can become part of our family in an unbiased learning environment. We uphold a zero-tolerance policy towards any form of disrespect or bullying towards staff or fellow students. We expect all students to demonstrate kindness, politeness, and good manners in their words and actions. Our goal is to promote a cohesive and respectful community where students work harmoniously together. To maintain a focused learning atmosphere, we do not permit swearing, stealing, fighting, or any other form of disruptive behavior. Additionally, the use of cell phones during program hours is strictly prohibited. Cell phones must remain in students' backpacks throughout the duration of the program, and failure to comply will result in confiscation.

Discipline

At Homework Club, we maintain high expectations for student behavior, and it is essential that all students respect our rules and guidelines. In instances where a student does not adhere to these expectations, we will initiate a conference with their parents to address the concerns. Students who continue to disregard the rules may be removed from the group to work directly with the administrator. Our priority is to ensure that every student works in a happy and safe environment. In many cases, behavior issues can be resolved through private conversations with the student. We make every effort to address these concerns before involving parents. However, if the behavior issues persist despite our interventions, the child may be asked to be picked up from the program. It's important to note that any form of discipline or punishment that violates a child's personal rights is strictly prohibited, regardless of authorized representative consent or authorization. Students will never experience corporal punishment, denial of snack breaks, or denial of restroom use under any circumstances. Our ultimate goal is to create a positive and supportive learning environment where every student can thrive.

Admission Policy

To enroll a student at Homework Club, we require an interview with the parent/guardian and the child. Before attending, parents must complete an enrollment application packet. Upon request, we can schedule a quick observation of the program to provide parents with insight into our activities and environment. We are committed to transparency and communication with our families. Therefore, we will provide a 30-day notice to the parent/guardian regarding any changes to the Homework Club program, tuition, policies, or procedures. This ensures that parents are informed and have sufficient time to adjust to any updates.

Termination of Contract

The contract with Homework Club may be terminated by providing a 10-day written notice to the Director of the club. Additionally, Homework Club reserves the right to terminate the contract for the following reasons: Student's continuous bad behavior, which includes but is not limited to: Interruption of class, Bullying, and Disrespect towards staff and other students. Prior to termination, the student will receive three warnings and parent conferences to address the behavior concerns. If the behavior persists despite interventions, Homework Club may proceed with the termination of the contract.

Snacks and Breaks

Students at Homework Club will have scheduled 30-60 minute breaks during their sessions, which can be spent in the classroom or in the schoolyard. These breaks will be supervised by our staff to ensure the safety and well-being of all students. We encourage students to bring their own snacks and lunch to enjoy during these breaks. However, if needed, Homework Club may provide a small snack consisting of prepackaged non-perishable food items. Our priority is to ensure that students have the opportunity to refuel and stay energized during their time with us.

Medication Policy

Homework Club staff are not trained to administer ANY type of medication to students. Thus, medication will not be administered by our staff or stored on location.
